Omnibus Spending Package Includes Funding for Federal PILT

SACRAMENTO, CA – December 18, 2015 –The Rural County Representatives of California (RCRC) announced today that Congress passed the Fiscal Year 2016 Omnibus Appropriations Act (Federal Spending Package), the federal spending package that supports a variety of government programs and services, including the Federal Payment in Lieu of Taxes (PILT) program. Federal PILT funding mitigates the impact to county governments from the losses in property taxes due to nontaxable federal lands within government boundaries. RCRC and its member counties have strongly advocated for Federal PILT throughout the year, and applaud Congress for this 2016 reauthorization.

Constitutional Amendment to Amend Proposition 218 Filed

A coalition including the Association of California Water Agencies, the California State Association of Counties, and the League of California Cities has filed a constitutional amendment that would create a new, optional funding method local agencies could use at their discretion to finance stormwater, flood control, and other water-related projects, and pursue conservation-based water rates or lifeline rates for low-income households.

Federal Update

Congress Adopts Fiscal Year 2016 Omnibus Spending Package

On Wednesday, December 16, 2016, Congress unveiled their Fiscal Year 2016 Omnibus Appropriations Act, which contains slightly more than \$1.15 trillion to support a variety of government programs and services. While the spending package does contain funding to support the Federal Payment in Lieu of Taxes program as we have been advocating for, it does not include key policy riders to address several issues that RCRC has worked on throughout the year. The House adopted the FY 16 Federal Omnibus spending package this morning in a 316-113 vote, followed by passage in the Senate with a 65-33 vote. White House Press Secretary Josh Earnest urged Congress to pass the spending measure earlier this week, signaling President Obama would likely approve of the measure when it reaches his desk.
