## LEGISLATIVE UPDATES

### SMALL VICTORY FOR COUNTIES AS SUPREME COURT RULES AGAINST ARMY CORPS IN WATER CASE

The Supreme Court has ruled unanimously in *United States Army Corp of Engineers v. Hawkes* that an approved jurisdictional determination (JD) that a property contains "waters of the United States (WOTUS)" amounts to final agency action and may be immediately challenged in court.

### HOUSE PASSES BILL TO DELAY IMPLEMENTATION OF EPA OZONE RULE

On June 8, the U.S. House of Representatives passed the Ozone Standards Implementation Act of 2016 (H.R. 4775) by a vote of 234–137. H.R. 4775 would delay implementation of the U.S. Environmental Protection Agency's (EPA) 2015 National Ambient Air Quality Standards (NAAQS) for ozone from 2017 until 2025

### DOL'S OVERTIME RULE TARGETED BY SENATE REPUBLICANS

On June 7, 2016, Republican senators introduced a resolution of disapproval (S J Res 34) aimed at stopping U.S. Department of Labor's (DOL) new overtime rule. The measure, introduced by Sens. Lamar Alexander (R-Tenn.) and Ron Johnson (R-Wis.), has support from more than 40 other Senate Republicans, including Majority Leader Mitch McConnell (R-Ky.).
