CONWAY RANCH STRATEGIC FACILITY PLAN

On October 20, 2015, the Mono County Board of Supervisors directed staff to engage in a public process to develop a Conway Ranch Strategic Facility Plan (CRSFP) that will guide future activities, maintenance, and development of the property.

The CRSFP will identify the current baseline activities and infrastructure at Conway Ranch, will identify a master vision for the future, and will identify the projects necessary to reach the master vision. Those projects can then be prioritized and funded as resources become available.

The intent of the public process is to obtain input on the master vision and related priorities. All concepts must be in compliance with the existing conservation easement and grant restrictions. Public input will be rolled into a draft Strategic Facility Plan that will be considered by the Board of Supervisors.
